## **Subject: Expression of Interest (EOI)**

ONGC Videsh, Dhaka, Bangladesh is planning to drill two offshore wells, one each, in Block SS-04 and Block SS-09 of Bangladesh. The wells are located in the South-East Bangladesh. Structurally, the blocks are part of NW-SE trending southern Tripura-Chittagong Fold Belt, which is having prolific gas fields in both India and Bangladesh. The main reservoirs are of Miocene-Pliocene (Bokabil /Bhuban) age. Most of these gas fields are clustered in onshore part of Bangladesh (gas fields like Bibiyana, Rashidpur, Titas, etc.) and in Indian state of Tripura (gas fields like Gojalia, Rokhia, Baramura, etc.). Sangu is the only offshore gas field in Bangladesh, situated within SS-04 block.

ONGC Videsh Ltd. (**ONGC-VL**) with 45% PI is the Operator of both the blocks. Oil India Ltd. (**OIL**) has 45% PI and rest 10% PI is held by the local National Oil Company of Bangladesh, BAPEX. ONGC-VL is seeking Expression of Interest from the interested vendors to drill two offshore wells Titli-1X in Block SS-04 and Maitri-1X in Block SS-09 as per the brief details tabulated below.

The Contractor (by himself or partner/sub-contractor) is required to ensure qualified well engineering services throughout the lifecycle of wells, including but not limited to, planning, procurement, drilling and testing campaigns till the wells are safely plugged and abandoned. Vendors may suggest & provide tentative plan for parallel or sequential approach to be adopted to drill the wells. Vendors are also directed to suggest whether integrated or bundled approach will be prudent to be adopted.
